## 3. PROFILE OF SKILLS AND COMPETENCES

- Possession of extensive pedagogical and didactic training so as to be able to provide socio-pedagogical support, educational and care work in institutions for children, young people and young adults
- Theoretically based planning, execution and evaluation of person, age and task related support, educational and care work
- Plan, execute and evaluate measures for intercultural learning and for health and environmental education
- Plan, execute and evaluate measures for the specific fostering and integration of children, young people and adults with support requirements
- Cooperate with other key workers (doctors, psychologists, therapists) and with representatives of other educational institutions
- Advise and support parents and guardians
- Shape and manage communication processes with the assistance of negotiating and conflict management instruments
- Lead and coordinate work and communication processes in interdisciplinary teams
- Apply well-founded pedagogical, psychological and sociological knowledge and skills in support and educational work conducted with the target groups and achieve participation of all those involved
- Theoretically based planning, execution and evaluation of educational processes in the creative field (e.g. music, design, play, media, movement and children's and young people's literature) and in early years education (e.g. language support, early support in mathematics and science)
- Apply business and legal knowledge in the designing of socio-pedagogical activity
- Support and coordination of structural and conceptual developments within the respective work and organisational unit
- Document and evaluate educational support and educational processes
- Accord due consideration to basic legal principles relevant to the occupation in carrying out educational support, educational and care work and in dealing with administrative matters within the given administration structures
- Communicate and cooperate in teams and manage group processes
- Develop a sense of initiative and assume responsibility within socio-pedagogical processes
- Use knowledge of foreign languages in a way which is adequate to the situation
- Demonstrate ethical, economic and ecological awareness within the context of sustainable development

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

State final examination:

1. following completion of training within the scope of the curriculum stipulated at a trade and technical school/ trade and technical academy or
2. following admission as a non-pupil by the education authority of the federal state.

**Additional information**

**Entry requirements:** intermediate secondary school leaving certificate or an educational qualification recognised as equivalent and completion of relevant vocational education or training or of training deemed to be equivalent in accordance with the regulations of the federal states

**Duration of training:** at least 2,400 hours of theoretical training and at least 1,200 hours of practical training

**Educational aim:** Trade and technical schools/trade and technical academies are institutions which provide continuing vocational training for the assumption of management tasks. Trade and technical schools/trade and technical academies offer a range of organisational forms of teaching (full-time or part-time basis) which lead to a post-secondary state vocational education and training qualification in accordance with federal state law.

Note: in accordance with the regulations of the respective federal state, qualification as a state-recognised educator takes place via successful completion of the course and, in some circumstances, following successful completion of an accompanying one-year practical placement.
